The Board does not consider that this released facility might interfere or might reasonably be seen to interfere with these directors' capacity to bring an independent judgement to bear on issues before the Board.
		An entity controlled by Paul Collins holds 500,000 convertible notes issued by the Company. The full terms of these notes were set out in the Company's Notice of 2022 Annual General Meeting. Given the quantum of the convertible notes, the Board does not consider that these convertible notes might interfere or might reasonably be seen to interfere with Paul Collins' capacity to bring an independent judgement to bear on issues before the Board.
		Emma Dobson holds 5,000,000 options granted by the Company with performance milestones. The Board does not consider that these options might interfere or might reasonably be seen to interfere, with her capacity to bring an independent judgement to bear on issues before the Board and to act in the best interests of the Company and its security holders generally. Given that the performance milestones concern market share price movements, the Board considers that the options help to align her interests with shareholders generally.
		Paul Collins was first appointed as a director of the Company on 19 October 2018.
		Trent Lund and Randolf Clinton were appointed as directors of the Company on 28 January 2021.
		Emma Dobson was appointed as a director of the Company on 1 February 2021.
